BCB's Food Fair will be a place to gather information, tips and resources for ways to stretch your food budget, access local resources and be sure that we all have access to nutritious foods. You may even learn about foods you've never tried! Sponsored by Humana, the food fair will bring together several agencies to talk about all things food-related, such as how to sign up for God's Pantry Food Bank, eligibility for food stamps, nutrition and diabetes, and additional resources for supplemental food. The Fayette County Extension Office will demonstrate food prep, including tasty samples! God's Pantry Food Bank will be on site to help participants apply for or renew / recertify their existing SNAP case. If you have documents you need to submit, bring them and the representative can help you upload those documents directly into the portal, and let you know if there are any other open document requests.

There will be a sack lunch to take home, and we will hold our monthly food distribution during the event. BCB's food distribution service is for anyone who is blind or visually impaired and could use extra groceries to help with the monthly budget and to help ease the burden of shopping with a vision impairment.

A Message from Lextran WHEELS:

October 14, 2022

Dear Lextran WHEELS Customer,

By now, you are probably aware that the Lextran WHEELS paratransit program has undergone some operational changes. The Lextran WHEELS paratransit service was operated by the American Red Cross for more than 40 years, as a subcontractor to Lextran. However, organizations develop and change over time, and the Bluegrass Chapter of the American Red Cross stepped away from paratransit service to focus on their mission-critical work: disaster relief, emergency preparedness and training, blood services, and support for the Armed Forces. However, many of the familiar faces and familiar voices you're grown accustomed to with your WHEELS service over the years will continue to be present with RATP Dev USA. RATP Dev USA began operations in Lexington on October 1.

RATP Dev USA, headquartered in Fort Worth, Texas, brings more than 50 years of success in managing and operating high-quality, safe, responsive and efficient transit systems throughout the United States. The local management team is proud to serve the city of Lexington and will support the company mission to achieve a more mobile and connected community with the experience and resources of RATP Dev USA.

Lextran will continue to work closely with RATP Dev USA to provide the professional and timely paratransit service that the citizens of Lexington expect and deserve. Lextran is excited about the future of the WHEELS paratransit program and its continued growth and improvement.

While there are some changes underway, there are also things that will remain consistent. What will remain the same:

- For trip reservations, you will continue to call 859-233-3433 be sure to dial 859!
- If you are currently eligible for Wheels paratransit service, your eligibility does not change.
- Your price you pay per trip will remain the same and you may continue to use your purchased passes.
- The Fayette County service area will remain the same the locations where your trip can begin and end will not change.
 Current subscription trips will remain active.
- The hours and days of service will remain the same.
- Approximately 90% of the current employees have transitioned and will continue to provide service, as employees of RATP Dev.

You can also expect:

- Employee Uniforms The new RATP Dev shirts are UK Blue instead of the red you're used to seeing.
- Vehicles will be marked with the RATP Dev logo, along with the Lextran WHEELS logo.
- Lextran and RATP Dev are conducting a process known as "trip negotiation," an ADA approved practice that allows for a trip to be scheduled one hour before or after the desired departure time. This practice will allow for greater system efficiencies and the ability to better accommodate more trips.
- We have added more vehicle types to the fleet, including ADA-accessible vans.
- We have added a dedicated telephone line for complaints or commendations at Lextran – call Lextran at 859.244.2030 if want to leave a compliment about your service or have a complaint.
- New faces! RATP Dev is actively recruiting new operators (drivers) to better accommodate your trips and meet the standard of service you expect.

As a reminder, all trip reservations should be made by 5 p.m. the day before the requested appointment. Same-day trip requests may not be accommodated due to capacity limits.

In the near future, we will roll out a smartphone application that will allow customers to see where their bus is located, and the status of the trip in real time. A dedicated phone line will also provide this information for customers without access to a smartphone.

Also coming soon, Lextran and RATP Dev will issue an updated Rider's Guide to all active riders with information that is easier to read and understand. It will also have clear rights and responsibilities for passengers and answer questions about how to schedule a ride and what to expect once onboard.

Thank you for your patience as we navigate this transition together and thank you for riding!
